22/12-05	Verbal Reports from the Director of BMSU and Named Persons
	The Director of BMSU has become aware that the chief Executive Officer and the Science Manager of
	FRAME which is the Fund for the Replacement of Animals in Medical Research visited an Animal
	research Unit at a UK University and then wrote a blog about the visit, which has now been posted.
	FRAME are strongly against the use of animals in research, however the blog provides a relatively
	balanced view, highlighting the caring attitude the people they met have to animals and the welfare
	they undertake. It also highlighted how they recognise that replacement is the hardest of the 3Rs to
	address. A link to the blog will be circulated to AWERB members. It was agreed that this was a very
	positive outcome given the remit of FRAME
	PPL holders have been contacted to request that all work requests are submitted in plenty of time prior
	to the Christmas period. All PPL holders have also been informed of the last ordering dates before Christmas.
	The Laboratory Animal Science Association (LASA) 2-day meeting was held on campus last week
	with good attendance from UoB. The meeting was well received with a presentation from a member of
	the university included in the 3Rs section. This talk was awarded the 3Rs prize.
	Senior members of the BMSU team are named as authors on a paper regarding refinement of arthritis
	models; this has now been accepted for publication.
	One of the Senior Technicians who is trained in performing regulated procedures will be leaving
	BMSU at the end of December but this will not impact on welfare or users as all other Senior
	Technicians are also fully trained and competent in performing these procedures.
	There are no concerns regarding animal welfare.
	A new cage washer is being installed in the service area during summer 2023 which will allow for the
	washing of racks and also has the capability of vaporised hydrogen peroxide (VHP) sterilisation for
	items which cannot go through the autoclave. This installation should not cause any disturbance to the
	animals.
	The Director reminded AWERB that Named Persons hold regular meetings (approximately every 4-6
	weeks) during which reports regarding animal mortalities and ill health are reviewed to monitor for any
	patterns or arising issues. Currently, no issues have been identified, including during significant
	building work external to, but local to the BMSU.
	With the support of AWERB and the BMSU strategy group, the BMSU Director and Deputy Director
	have been providing talks to PIs across the different Institutes in the Medical School regarding changes
	in Home Office processes, and an update on how BMSU functions and why.
	The Home Office have continued to undertake Facilities Audits at other Establishments; reports
	suggest that these focus on application of the 3Rs and the processes in place to ensure compliance with
	standard conditions of the various licences. The Home Office are hoping to undertake some thematic
	audits in the future, but we are awaiting further details.

	The new training and competency module in our database is now fully tested and scheduled for release
	to the users on a step-by-step basis. BMSU have received a few FOIs, one relating to whether the University has undertaken a wildlife
	survey on campus: information of the Hedgehog Friendly campus has been provided as an example.
22/12-06	Report from the Fast Track Procedure
	Up to date with Fast Track and everything is going through as would be expected.
22/12-07	Review of AWERB activities 2022
	BMSU currently have 297 personal licence holders and 76 project licences. During 2022, AWERB has
	processed and had approval for 24 amendments to project licences and had 12 new project licences
	granted.
	The average iterations (number of times the Home Office returns an application prior to granting the
	licence) is 2.8 across the UK. Of the 12 applications submitted by the university, 11 have been granted
	with no comments which have had to be addressed (i.e. zero iterations). This is reflective of the high
	standard of applications which are finally submitted to ASRU via AWERB. In this context the Home Office has issued new guidelines for project licence applications; it has been confirmed that the advice
	provided in the document aligns with that already being provided to applicants by BMSU.
	For <i>in vivo/ex vivo</i> work undertaken in collaboration with UoB but outside of the university (PEL),
	AWERB has considered and made decisions on 2 UK-based applications (collaborations under a PPL
	held at another Establishment), 8 applications which fall outside of ASPA (use of protected species for
	non-regulated work), and on 3 applications where animals are being used overseas (where it would
	have been under ASPA had it been performed in the UK).
	BMSU have also provided CPD refresher training for all PPL holders.
	All of this data will be included in a report for the Research Governance Ethics Committee.

	 The NC3Rs Regional Programme Manager will now lead the 3Rs Focus Group.
	• UoB researchers are being encouraged to participate in an NC3Rs Experimental design
	survey. The results will be used to inform future experimental design training provided at the
	 university by the NC3Rs Regional Programme Manager. The NC3Rs Regional Programme Manager is running a workshop on the ARRIVE guidelines
	for new PIL holders on 26 January 2023 10:00-12:00. It will include advice on some key
	aspects of experimental design.
	 Responsible Research in Practice are running an online course on "Statistical Analysis for In
	Vivo and In Vitro Scientists". Tuesday 6 December to Thursday 8 December
