

## Leadership and Management for Social Care MA/Postgraduate Diploma



The Leadership and Management Programmes offered by the Institute of Applied Social Studies (IASS) provide critically aware and research-based knowledge relating to the crucial areas of leadership and management practice for social work and social care. It is designed to provide this as flexibly as possible, in order to meet a broad range of candidate and organisational needs.

Candidates can choose to study a single module; a Postgraduate or Graduate Certificate (3 modules); a Postgraduate or Graduate Diploma (6 modules) or a Masters in Advanced Practice (6 modules and a dissertation).

**Type of Course:** Continuing professional development, taught

### Details

The programme is designed to provide candidates with systematic understanding, knowledge and skills relating to all the core functional areas of management and leadership practice and the development of advanced level professional capability. The modules focus on different aspects of management practice. However, each module also connects with all the other modules in reflecting the key management functions - those of management of self and personal skills, provision of supervision, change facilitation work with people, use of resources and the achievement of results. The programme is available to staff from varied disciplines and professional settings, particularly those from Social Work and Social Care, Health, Youth and Community Justice.

Candidates may complete three modules of their own choice in order to receive either a Graduate or Postgraduate Certificate in Leadership and Management for Social Work or Social Care.

It is a particular feature of this programme that any module can be undertaken on a stand-alone basis, to reflect the needs of a particular leadership role or organisational purpose.

Candidates for the PG Diploma award undertake six modules out of a choice of seven modules. The resulting six-module sequence will form a 120 Credit Graduate Diploma or Postgraduate (M level) Diploma in Leadership and Management for Social Work or Social Care. For those completing the Postgraduate Diploma, there is the option to continue to the Masters Award in Advanced Practice (a further 60 credits) through the completion of a 10,000 word dissertation on a topic that reflects the candidate's area of interest.

The design of the programme is informed by the Professional Capability framework for Social Work and will support the development of those capabilities at the

## Fees and funding

### Fees for 2015-2016:

- 1 module: £588
- 3 modules (PGCert): £1,764
- 6 modules (PGDip): £3,528
- Masters (MA): £1,764

Following the completion of the Postgraduate Diploma, there is the option of progression to a Masters Award (60 credits), through the completion of the Research module and dissertation; the fee for this is £1,764.

## Assessment methods

These reflect face to face teaching which is characteristically interactive, guided learning and group tasks together with guided study.

Academic assessment is comprised of a written assignment per module (3000 words). This assignment specifically requires candidates to connect knowledge, values and critical analysis to their experience of leading and managing in the workplace.
