## Learning and teaching

The MSc programmes provide students with an advanced training in core areas of economics, while also enabling them to specialise according to their interests. They reflect the rapid expansion of the subject in recent years, and deal with topical issues. The aim is to train students for careers as economists or managers in commerce, industry, banking, financial services or the public sector. Module assignments, and in particular the dissertation, provide an initial training in the kind of skills needed for the independent investigations which are likely to be important in professional careers. For students proceeding to research training, the MSc programmes provide much of the basic methodology and techniques required.

## Assessment methods

A number of methods of assessment are used in the Business School, including assignments, group work, presentation, and examinations. The method(s) of assessment for each module will be detailed in the Module Description.

The most common forms of assessment used are written assignments and exams, and information on these is given below. Help and guidance on other forms of assessment will be given in the module in which they are used.

## Employability
