

Migration, Superdiversity and Policy MA/PGDip/PGCert

The MA Migration, Superdiversity and Policy will explore the social, economic and political impacts of international migration and examine current, proposed and ideal approaches to welfare provision in the era of superdiversity. It will explore data to help map superdiverse populations and examine the rights and entitlements of migrants in different societies. Taking an applied approach, the programme will help students to learn how to access data sources and undertake research in ways that can increase understanding of the nature of superdiversity and the needs of superdiverse communities.

Details

The MA Migration, Superdiversity and Policy will explore the social, economic and political effects of the new era of migration and consequent emerging superdiversity. It will analyse the multiple variables displayed by different migrants in terms of age and gender profiles, as well as immigration status, and associated rights and entitlements.

It will also address the ways that social policy has been created and adapted in order to accommodate the changing fabric of urban and rural populations that have experienced high levels of inward migration. Students will critically examine the suitability and adaptability of traditional multicultural models of welfare provision that were originally based upon providing for large and geographically contained clusters of post-colonial migrants and explore a range of new approaches to service delivery focusing on good practice from across the world.

The MA Migration, Superdiversity and Policy will allow students to consider new ways that the needs of diverse populations may be met and how to overcome challenges such as lack of demographic information and details about need.

Placements, internships and support

Students on the programme will have the opportunity to undertake a work-based internship in a migration related organisation. Small bursaries to undertake mini-research projects

Small bursaries to undertake mini-research projects in a student's specialist area of interest relating to migration, superdiversity and policy are also available. Students are required to submit a short proposal outlining their research ideas in order to be considered for an IRIS research bursary.

Modules

Students studying for the **Postgraduate Certificate** must complete three **20 Credit modules** including the core module listed below:

- **Migration, Superdiversity, Policy and Practice (20 credits)**

This module examines theories surrounding migration and superdiversity paying particular attention to the policies and politics that shape responses to migration from a global to local level. It challenges students to think critically about migration and the impact upon policy and the provision of social welfare and to examine reactions and responses to migration from a range of contrasting perspectives. It encourages students to reflect on ways in which migration is shaping questions about citizenship, inclusion, identity and cohesion at different policy levels.

Assessment methods

On completion of the taught modules (120 credits) Masters students undertake a 10,000 word dissertation on a new migration related subject of their choice. Each student is allocated an experienced specialist supervisor, selected for their knowledge of both the subject matter and supervision skills.
