Evelyn Ellis began work at the University of Birmingham in 1972. She was Professor of Public Law between 1996 and 2008 and is now an Emeritus Professor at Birmingham Law School. Her main research interests lie in the field of anti-discrimination law, in particular the EU aspects. She has written a number of books which include: *Sex Discrimination Law* (Gower, 1988), *European Community Sex Equality Law* (Oxford University Press, second ed. 1998), *Public Law of the European Community: Text, Materials and Commentary* (with T Tridimas, Sweet & Maxwell, 1995), and *EU Anti-Discrimination Law* (OUP, 2005) She edited and contributed to *The Principle of Proportionality in the Laws of Europe* (Hart, 1999) and also edited and contributed to *Equality into Reality: Action for Diversity and Non-Discrimination in Iceland* (University of Iceland, 2012), She is currently preparing a second edition (for publication in 2012) of *EU Anti-Discrimination Law*, in collaboration with Professor Philippa Watson. She continues to be a regular visitor to the School.

Biography

Evelyn Ellis was Professor of Public Law between 1996 and 2008 and is now an Emeritus Professor at Birmingham Law School. She was Head of School between 2000 and 2003. She is currently an Adjunct Professor at the University of Western Australia, where she teaches comparative Torts Law. She also teaches EU Law at the Jersey Institute of Law.

Evelyn's many published articles and contributions to collected works have focused on discrimination law, especially that of the EU, and she wrote a paper on this subject for the Cambridge University Independent Review of the Enforcement of UK Anti-Discrimination Legislation (1999). In 2000, she acted as a specialist adviser to sub-committee F of the House of Lords Select Committee on the EU during its enquiry into two proposed directives on discrimination law. She has also written widely on discrimination on religious and political grounds in Northern Ireland and was co-author (with George Applebey) of a Report to the Standing Advisory Commission on Human Rights on the operation of the Fair Employment Agency. This report formed the basis for the Fair Employment (Northern Ireland) Act 1989. She is a regular speaker at conferences on equality law, especially under the auspices of the Academy of European Law, Trier, Germany.
