Linda has a background of experience as a teacher of the deaf and educational audiologist and her research and teaching are rooted in this experience. She is particularly interested in the early language and literacy development of young deaf children and how this can be enhanced by the use of cochlear implants and/or digital hearing aids. She has a collaboration with the University of Melbourne where colleagues share these specialist research interests.

The School of Education has the largest course for providing training for teachers who wish to gain the mandatory qualification to teach deaf children, and Linda is programme co-ordinator.

Linda brings to all her roles skills gained from training as a counsellor and she is interested in the role of supervision of educational psychologists and teachers of pupils with special needs.

Teaching

Linda Watson is a member of Department for Disability Inclusion and Special Needs (DISN), which comprises a large group of academics that is recognised for its excellence in researching and teaching in both general and specific areas of disability and special needs and educational psychology. In this role she supports the department and its members in the strategic development of teaching and research related to disability, special needs and educational psychology.

She is joint programme co-ordinator for courses in deaf education that lead to the mandatory qualification as a teacher of the deaf. She contributes sessions related to deafness to other programmes at different levels, including training of educational psychologists.

Postgraduate supervision

She supervises 13 research students who are researching a variety of topics in education, either as Mphil/PhD students or as part of the EDSN strand of the EdD for which she has responsibility.
