Biography

Martin Trybus read law at the Free University of Berlin before completing his studies for a LL.M. in Business Law (1995) and for a Ph.D. (1997) at the University of Wales, Aberystwyth. He qualified in Germany, having also completed a stage with the European Commission in Brussels (1999), before starting as a lecturer at the University of Nottingham (2000). He was visiting scholar at George Washington University Law School in Washington DC (2003), at the University of Cape Town (2004), and visiting fellow at the University of Utrecht (2004). An AHRC Research Leave Award (2003-2004) led to his *European Union Law and Defence Integration* (2005). At the beginning of his Senior Lectureship at the University of Sheffield (2006) he was seconded as Senior Adviser to the SIGMA programme of the Organisation for Economic Cooperation and Development (OECD) in Paris where he coordinated a number of major studies on public procurement in Europe financed by the European Commission. Professor Trybus joined Birmingham Law School in 2007. He is currently member of the Procurement Review Board of the European Space Agency (ESA).

He is currently working on a monograph on the new EU Defence Procurement Directive for Cambridge University Press and on two edited collections, one on the Lisbon Treaty with Luca Rubini for Edward Elgar and one on the EU Law of public contracts with Roberto Caranta and Gunilla Edelstam for Bruylant (Brussels).

Other activities

Professor Martin Trybus has been involved in consultancy projects for the British, Dutch, and French governments, the European Defence Agency, the European Commission, the European Space Agency, and the OECD. These projects concerned public procurement regulation, in particular public procurement reform in Central and Eastern Europe and the legal aspects of the European armaments market. In 2008 he gave evidence to the European Parliament on the 'defence package' of armaments related directives and is currently the legal expert on a project lead by RAND Europe providing research for the European Commission on the Defence and Security Procurement Directive. Apart from Birmingham he teaches regularly at the International Training Centre of the International Labour Organisation in Turin and the European Institute of Public Administration in Maastricht. In 2010 Professor Trybus was appointed to the Procurement Review Board of the European Space Agency in Paris. In 2014 he was also appointed **Senior Research Fellow of the think tank RAND Europe** ([/research/activity/iel/news/2014/trybus-rand.aspx](http://research/activity/iel/news/2014/trybus-rand.aspx)) and served on the jury of the **European Law Faculties Association (ELFA) Thesis Prize** ([/research/activity/iel/news/2014/trybus-elfa-thesis.aspx](http://research/activity/iel/news/2014/trybus-elfa-thesis.aspx)). He is also serving on the jury of the International Procurement Award Thesis Prize and the Academic Advisory Board of the German Procurement Association *Forum Vergabe*.

Professor Trybus is the Director of the **Institute of European Law** ([/research/activity/iel/index.aspx](http://research/activity/iel/index.aspx)) . (<http://www.birmingham.ac.uk/research/activity/iel/index.aspx>) organising, inter alia, the Future of European Law and Policy conference series.
