About

I see myself as a medievalist with an extension into the sixteenth century, and as someone with a particular passion for teaching these still deeply relevant periods to modern undergraduates.

Qualifications

I did my first degree at Birmingham (French and German) and my doctorate at Oxford, and have spent my entire career in the Birmingham German Department.

Teaching

As the Department's specialist in medieval and early modern literature, I teach a number of courses in these fields at second- and final-year level. My second-year course, entitled 'Knights, Maidens and Priests', focuses on a diverse range of short medieval and sixteenth-century texts, whereas my long established final-year course, 'Epic and Romance', currently deals with the *Nibelungenlied*, Gottfried von Strassburg's *Tristan*, and works by Hartmann von Aue. I also contribute to the first- and second-year core courses in German literature, supervise postgraduate research into the medieval and early modern periods, and do a wide range of language teaching.

Postgraduate supervision

I am keen to supervise postgraduates working on medieval or sixteenth-century German culture. I currently have two doctoral candidates, one working on the *Schachbuch* of Heinrich von Beringen and its relationship to the relevant Latin tradition, and the other (co-supervised with Nicholas Martin) on Kafka and Thomas Mann's reception of Hartmann von Aue's *Gregorius*. In recent years I have supervised or co-supervised theses on such diverse themes as Utz Eckstein's Reformation treatises, Albrecht Dürer's scientific writings, Max Mell and Reinhold Schneider's reception of the *Nibelungenlied*, and the important fifteenth-century German manuscript British Library Add. 24946.

Research

Much of my research activity is devoted to three sometimes related interests: allegorical and symbolic uses of animals in medieval literature; late medieval didactic literature (in Latin and German), and its methods of conveying religious and ethical ideas to an increasingly wide audience; and the ways in which certain authors of the High Middle Ages adapted their French sources. I find myself also developing an increasing interest in the Swiss Reformation. I am currently working on a set of studies of medieval animal imagery, on the various versions of the late-medieval theological compendium known as the *Lumen anime*, and on the Zurich reformer Huldrych Zwingli.
