Aims

This project aims to contribute to the emergence of a sociology of statelessness that explores contemporary manifestations and experiences of statelessness, both individually and collectively. It investigates in particular how members of a 'stateless diaspora' negotiate, mobilise and/or resist, and ultimately problematise, notions of shared belonging in the EU. Against the background of fluid, and at times conflicting, EU and EU member states' immigration and citizenship regimes, the study will examine 'emic' and 'etic' discourses in relation to the categorisation of Roma people as 'stateless diasporas'. Through an in-depth qualitative analysis, the project will investigate the processes through which both statelessness and diasporic identity and identification are constructed, adopted and/or rejected by individuals and states.

Key research questions

The main aim of this project is to investigate comparatively the ways in which Romani communities living in Italy and the UK are impacted upon by immigration and citizenship regimes in two EU member states, focusing in particular on individual and family experiences and settlement strategies, transnational engagement and diverse modes of mobilisation in the country of residence. In addition, this project also provides a timely analysis of the emergence and institutionalization of statelessness in the EU and the ways this process impacts 'stateless' people on the ground.
