Dr Jenny Harlock is a Research Fellow at the Health Services Management Centre, University of Birmingham. Her current research projects include a 3 year NIHR funded study into decommissioning healthcare services, and research on the role and implications for the third sector of health and social care reform. Jenny completed her doctoral thesis on the changing state-third sector relationship in public service delivery, focusing on social care for older people, in 2011. Jenny was previously a programme manager for the Department of Health Voluntary Sector Strategic Partnership Programme for the National Care Forum and Voluntary Organisations Disability Group.

Biography

Jenny Harlock joined HSMC in June 2013. Prior to this, and following completion of her PhD in 2011 at the University of Bath, Jenny was a Research Fellow at the Third Sector Research Centre, University of Birmingham. There she researched the impact and performance measures used by public sector commissioners to assess the effectiveness of third sector adult social care services, and their implications for third sector providers.

From 2009 - 2012 Jenny was a Programme Manager for the Department of Health Voluntary Sector Strategic Partnership Programme for the National Care Forum and Voluntary Organisations Disability Group. In this role she consulted on a number of policy and practice issues and initiatives, most notably personalisation and the then Health and Social Care Reform Bill. Earlier in 2009 Jenny led research into the implications of personalisation for an ESRC funded internship at the National Council for Voluntary Organisations (NCVO).

Whilst studying for her doctoral thesis at the University of Bath Jenny was a Graduate Teaching Assistant on a number of undergraduate courses including Research Methods and the Philosophy of Social Sciences.

Jenny's research has reflected her wider interest in health and social care reform, particularly changes in health and social care commissioning. She has particular interest in qualitative and interpretivist research methods.
