Postgraduate supervision

Professor James Arthur is a world leading expert on the Character and Values of young people and is Director of the Jubilee Centre for Character and Virtues. He has recently directed a project which completed the largest UK-based study into issues surrounding character development, looking at over 70,000 responses from young people aged 3-25 (see Learning for Life – www.learningforlife.org.uk (<http://www.learningforlife.org.uk>)).

Research

His major research activities currently involve the aspirations and character formation of young people in deprived areas. As well as being Director of the Jubilee Centre for Character and Virtues, he is also Director of Citzed – an organisation (funded by the TDA) in higher education promoting citizenship and is Director of a major research project on young people's values and character dispositions (see Learning for Life – www.learningforlife.org.uk (<http://www.learningforlife.org.uk>)) and Citzed – www.citzed.info (<http://www.citzed.info>)). He was a member of the National Forum for Values in Education and the Community. He has participated in various consultations with QCA about values education, and was a member of the History Task Group of the National Curriculum Council to revise the National Curriculum, and has since been a member of a sub-group of the Citizenship Working Party as well as a member of groups on citizenship and personal and social education in the DCSF and in the Teacher Development Agency.

Knowledge exchange and impact

He has produced a series of major research reports on citizenship and values education which have fed directly into policy decision making at national government level. He has also worked with the City of Birmingham on a Young International Citizens Award and collaborated with the University of Birmingham Guild of Students and the City of Birmingham on volunteering provision for the Children's University.

He was part of the University of Birmingham **Heroes** (<http://www.bham.ac.uk/heroes/index.shtml>) campaign to raise awareness regarding some of the current research that continue to address today's key national and global challenges. James Arthur is one of the featured academic experts from the School of Education and he can be seen talking about his work on the webcast.
