### About

Dr. Vlad Mykhnenko is a scholar, committed to the advancement of **geographical political economy**, with its focus on modern capitalist social formations as spatially and temporally uneven and highly variegated systems. To this end, he combines the theoretical insights and methodologies of Economic Geography, Urban & Regional Economics, and Comparative Political Economy.

Vlad has pioneered research on long-term growth trajectories of Europe's largest urban areas (Turok and Mykhnenko, 2007), in addition to authoring a series of trend-setting publications on shrinking cities (Mykhnenko and Turok, 2008; Haase et al., 2013) and urban resurgence (Turok and Mykhnenko, 2008). Furthermore, he has produced a number of rigorous, innovative, and internationally significant studies, uncovering the impact of the neo-liberal structural adjustment on regional economic performance across Europe (Mykhnenko, 2007; Swain and Mykhnenko, 2007; Birch and Mykhnenko, 2009; Mykhnenko and Swain, 2010; Mykhnenko, 2011; Birch and Mykhnenko, 2013).

Dr. Mykhnenko's recently edited volume on *The Rise and Fall of Neoliberalism* (Zed Books, 2010) has received a critical acclaim across the world, with special foreign editions of the book published in India and Serbia. See comments on this volume in the 'Publications' section.

Before completing a Ph.D. at Cambridge in 2005 on the political economy of regional economic development, Vlad had served as an International Policy Fellow at the Centre for Policy Studies, Central European University & Open Society Institute - Budapest. Dr. Mykhnenko subsequently worked as a Research Fellow at the Universities of Glasgow (Centre for Public Policy for Regions) and Nottingham (School of Geography), before taking up the lecturing position at Birmingham on 1 January 2012.

Dr. Mykhnenko has taught undergraduate and postgraduate students at a number of universities both in the United Kingdom and continental Europe, including Kyiv Taras Shevchenko, Kyiv Mohyla Business School, Cambridge, Glasgow, and Nottingham.

### Research interests:

Vlad's current research is aimed at exploring the interrelationship between spatial disparities in economic production, spatial disparities in living standards, and social inequality, both in the core industrially advanced economies as well as in the transition and emerging market economies.

Substantially, his research focusses on the following two subject areas:

- **The urban and regional economy:** local economic development; urban growth, decline, and shrinkage; regional economic convergence and divergence.
- **Income flows and local government finance:** fiscal federalism and local government finance; urban austerity, the spatial distribution of national income, and territorial cohesion; fiscal stress and fiscal resilience.

### Recent research grants

Dr. Mykhnenko's work has been funded by the UK Economic and Social Research Council (ESRC), the European Union's 7th Framework Programme in Socio-economic Sciences and Humanities (FP7-SSH), and a number of charitable foundations, including the Open Society Institute (OSI) and the Regional Studies Association (RSA). Overall, Vlad has contributed to obtaining £1,262,215 in external research funding, with his personal share amounting to £243,805. This externally-funded research has engaged extensively with policy makers and practice communities and has sought to assist key stakeholders in generating a better understanding of policy alternatives, avoiding the potentially harmful impact of industrial restructuring on the local economy and communities, changing spatial imbalances, and managing the spatial and demographic shrinkage of European cities.
