About

Helen Stokes-Lampard is a GP Principal and Primary Care Academic at the Department of Primary Care (Interim Head of Department), having started here in 2000 as a GP Registrar and progressed through the ranks to her current roles as Interim Head of Department of Primary Care, the Head of Academic Community Based Medicine Teaching across the whole of the MBChB (Medicine undergraduate) programme, she is also the Head of the dynamic Academic GP Trainee programme, which is the largest in the UK with 15 trainees in programme currently.

As Clinical Director of the Primary Care Trials Unit Helen was involved in advising on a diverse range of research projects. Since handing over the reins in 2012 she has remained interested in all areas of Primary Care research although she is no longer regarded as 'research active' she sees her primary research role as being focussed on enhanced communication between the research teams and coal face GPs and is happy to advise researchers on the pragmatic implications of their research ideas.

Helen was the Programme Director for the MSc in Clinical Primary and Community Care at the University for two years and remains the lead for the Community Gynaecology module.

Having many diverse roles outside the University, including being the Honorary Treasurer of the Royal College of General Practitioners (the largest Medical Royal College), being a mentor for 'doctors in difficulty' in the Midlands and her commitment to General Practice at The Cloisters Medical Practice in Lichfield, she is committed to the 'bigger picture' of academic research but also believes in high quality one-to-one patient contact and the value of continuity of care for chronic disease management.

Helen was initially funded by a Deanery initiative and then by two NIHR awards (doctoral and post-doctoral) so she recognises the importance of valuing and nurturing junior clinical academics and encouraging their careers through the early years.

Biography

Helen Stokes-Lampard qualified in Medicine from St George's Hospital Medical School, London in 1996. Initially contemplating a career in Obstetrics and Gynaecology, she underwent a Damascene conversion to Academic Primary Care and joined the Department at Birmingham in 2000 as an Academic GP Registrar. She quickly became involved in the RCGP and became a nationally elected representative for GPs in training which involved membership of several national committees including revising the assessment process for the new MRCGP examination.

Having successfully completed her GP Training in Birmingham she took up the offer of a post as a part time Principal at The Cloisters Medical Practice immediately after qualifying and simultaneously started at The University of Birmingham as an Academic Fellow.

Helen spent some time organising a highly successful national conference for GPs in training (GP or not to be?) she then focussed on her research career and gained a national fellowship to fund her doctoral studies and training.

Having completed her PhD she immediately took up the post as Clinical Director of the Primary Care Trials Unit (PCCRTU), one of the busiest and most successful Primary Care research units in the UK.

In Nov 2011 Helen was elected as Assistant Treasurer of the Royal College of GPs, taking over the full role of Honorary Treasurer in November 2012. From this point she handed over the leadership of the Trials Unit and took over as Academic Lead for the MSc in Clinical Primary and Community Care for two years. In 2014 she took over as Academic Head of Community Based medicine for the undergraduate Medicine programme for Birmingham (MBChB) and relinquished the MSc.

Helen became the Academic Lead for Academic GP Trainees at the University in 2010 and continues with that to the present.
