About

Rosie's research explores the place of law in everyday life. Her primary interests are in family law, particularly the regulation and recognition of caring and intimate relationships. She uses social science methods including both qualitative and quantitative approaches to empirical research to investigate the place of law in everyday life, including everyday understandings of law and legal discourse. Her work is grounded in feminist legal theory and gender, sexuality and law, and has been supported by research grants from the AHRC, ESRC and the British Academy. Her current research is focused on mental capacity, care, and dementia. She is working on a monograph, *Duties to Care: Dementia, Law and Relationality* (forthcoming, 2016, Cambridge University Press) Her broader research interests are in the gender, sexuality and law field, and also include human rights, discrimination and equality, and the intersection of law and psychology. Her first book, *Regulating Sexuality* won the 2011 Hart-SLSA Book Prize and Early Career Prize.

Research

Rosie's main research interests are in how law operates in everyday life. She is interested in how people experience legal frameworks and how they make decisions about whether or not to use law. Her research to date has focused on the recognition and regulation of intimate and caring relationships. Her work straddles areas of equality law, family law, healthcare law, human rights and jurisprudence.

Rosie's current research project seeks to understand how carers of people with dementia experience the regulatory frameworks surrounding accessing help with and financial assistance for care, and the sources of formal and informal support utilised by carers of PWD, through topics including recent changes to powers of attorney, and the personalisation of care budgets. This empirical work forms the basis of her current monograph project *Duties to Care: Dementia, Relationality and Law* (under contract with Cambridge University Press).

She was principal investigator of the AHRC Research Network 'ReValuing Care: Perspectives from Gender, Sexuality and Law' (www.revaluingcare.net (<http://www.revaluingcare.net>)), a partnership with the Universities of Adelaide, Keele and Queen Mary University of London, and is currently working on an edited collection of academic essays drawn from the network events with Dr Ruth Fletcher (QMUL) and Professor Chris Beasley (University of Adelaide).
