### About

Russell holds the Chair in Health Systems at the University of Birmingham where he is currently Director of Research at the Health Services Management Centre. He holds long standing university positions as Visiting Professor in the Faculty of Medicine, University of Oslo, Visiting Professor in the Centre for Clinical Governance Research, Faculty of Medicine, University of New South Wales, Sydney and Visiting Fellow at Bocconi University, Milan. He was previously Director of the Centre for Health and Public Services Management at the University of York and set up and directed the MSc in Health Management at York (2005-09).

Russell presents keynote lectures and seminars around the world and provides policy and research advice to a range of national and international governments and agencies, including: the World Health Organisation, OECD, the International Society for Quality in Health Care, the European Health Management Association, the European Union, Department of Health, HM Treasury, NHS Confederation, the Royal College of General Practitioners and the Department of Health in New Zealand, Brazil and Italy.. His work on organisational culture, health care quality and patient safety was used at evidence at the Mid Staffordshire NHS Foundation Trust Inquiry chaired by Robert Francis QC. He has won several international awards and prizes for his research including the Baxter European book Award.

Russell is an Associate Editor of the Journal of Health Organization and Management and sits on the editorial boards of the International Journal for Health Policy and Management; the International Journal of Public and Private Healthcare Management and Economics; and the Open Medical Informatics Journal. He is a member of the National Institute for Health Research HS&DR Commissioning Board and is currently an external examiner for postgraduate programmes at the School of Health and Related Research, University of Sheffield and the Faculty of Medicine, University of Malta. He is a member of the College of Reviewers for the Government of Canada and the Canada Research Chairs program.

Russell is currently leading a major national study into the effectiveness of hospital board governance of patient safety funded by the National Institute for Health Research SDO programme (2011-2015). The study is investigating the linkages between hospital governance and patient safety processes and clinical outcomes based on the collection and analysis of national quantitative patient safety data sets and in-depth case studies. The study involves colleagues from Dr Foster and the University of St Andrews.
