Biography

Robert Page was born in Hammersmith, West London. He gained both his BA and PhD degrees from the University of Kent. He was previously a Lecturer in Social Policy at St Davids University College, Lampeter from 1980-1988 before taking up a post as Lecturer in Social Policy & Administration at the University of Nottingham (1988 to 1998). He moved to the University of Leicester in 1998 as a Senior Lecturer in Social Policy and was awarded a Readership in Social Policy in 2000.

Since 2001 Robert has been a Reader in Democratic Socialism and Social Policy at the University of Birmingham. He has also taught on Social Policy and Social Science degree programmes at the University of Kent, the Open University, University College, Cardiff, the University of Loughborough, the University of Alabama and Umea University. He was a member of the Social Policy Association Subject Benchmarking Panel in 1999 and a member of the QAA National Benchmarking Panel for Social Policy from 1999-2000. He has served as a member of the Executive Committee of the Social Policy Association on three separate occasions (1994-1997: 2000-2003 and 2005-2007). He was a member of the editorial Board of the *Journal of Social Policy (JSP)* from 1994 to 2003). He acted as Reviews Editor for JSP from 1996-2003. He has been a member of the editorial board of the *Journal of Poverty and Social Justice* (formerly *Benefits*) editorial Board since 1990 and currently acts as Reviews Editor. Robert has been a Fellow of the Royal Society of Arts since 1998. He was a Leverhulme Study Abroad Fellow at the John F. Kennedy School of Government at Harvard in 2009. He is a member of the Social Democratic Philosophy Group, chaired by Matthew Beech of the University of Hull. Robert is a lifelong supporter of Fulham Football Club.

Robert currently teaches on both the BA and MA Social Policy programmes at Birmingham. His main teaching interest is the political history of the British welfare state since 1940.
