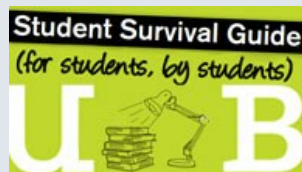

## First year

When you arrive in the Department of Accounting and Finance you will be allocated a personal tutor who will guide you through the three year course. As part of your first year of study, you will complete 7 core modules as well as having the opportunity to study two modules outside of accounting and finance.



You will also participate in the professional skills module which involves a trip to our activity centre at Coniston in the Lake District.

This unique activity provides an outward bound experience where you will face challenges with other students on the Accounting and Finance course, allowing you to develop key teamworking, leadership and presentation skills which you will build on throughout your degree in preparation for your future career.

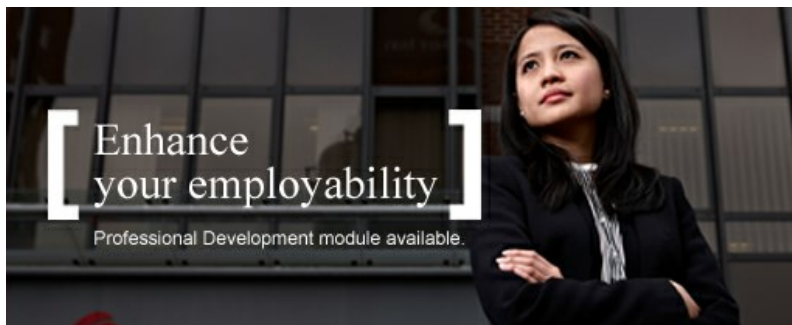
## Second year

During the second year you will build on the knowledge gained in year one by taking 9 intermediate modules. During this year will notice a focus on employability through a range of department organised events designed to help you secure a graduate position at the end of your degree.

## Third year

During your final year you will study 5 core modules and up to 3 optional modules. The modules you take in the third year are designed to bring your Accounting and Finance knowledge to a managerial level, equipping you with the tools you need to be successful at a senior level within the accounting and finance sector.

You are also able to take advantage of a unique opportunity by taking part in our Professional Development module which allows you to complete an internship and you are assessed by written assignments as part of your degree.

## Professional qualification exemptions

The BSc Accounting and Finance course offers several exam exemptions from professional Accounting and Finance qualifications:



This Accounting and Finance course is accredited by the Association of Chartered Certified Accountants (ACCA). Depending on the modules you study over the course of the degree and the results you obtain, you could secure exemptions from the ACCA exams, completion of which is required to become a chartered qualified accountant.



On successful completion of the Accounting and Finance course you may be eligible for exemptions from Chartered Institute of Management Accountants (CIMA) professional exams which need to be completed to gain chartered management accountant status.



In order to become a Chartered Accountant you need to complete some professional exams set by the ICAEW. On completion of the Accounting and Finance course depending on the modules you have studied and your performance you may qualify for exemptions.



The CISI has awarded the Department of Accounting and Finance the title of 'Centre for excellence in Finance teaching'. We are also one of the only universities in the UK where depending on the optional modules you take, you could be awarded a CISI diploma in investor advice on completion of your degree. This can then be used to obtain FSA approved person status making you employer-ready in the city.

## Why study this course

- The Accounting and Finance department is one of a select few institutions in the UK that have been recognised by the Chartered Institute of Securities and Investment (CISI) as a centre of excellence for finance teaching.
- 89% of our graduates go on to work or undertake further study, aided by the department's links with industry and course specific internships. - On successful completion of your degree you may be eligible for exemptions from some professional examinations offered by the Association of Chartered Certified Accountants (ACCA), the Institute of Chartered Accountants England and Wales (ICAEW) and the Chartered Institute of Management Accountants (CIMA). We are also the only UK university where you could walk away with a CISI diploma in investment advice.

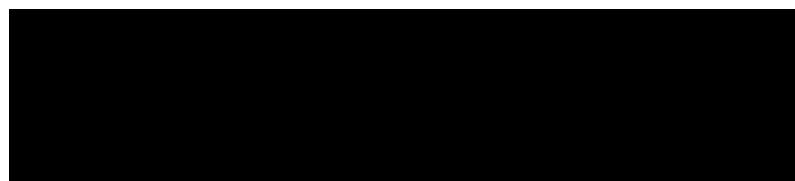

## Key Information Set (KIS)

Key Information Sets (KIS) are comparable sets of information about full- or part-time undergraduate courses and are designed to meet the information needs of prospective students.

The development of Key Information Sets (KIS) formed part of HEFCE's work to enhance the information that is available about higher education. They give you access to reliable and comparable information in order to help you make informed decisions about what and where to study.

The KIS contains information which prospective students have identified as useful, such as student satisfaction, graduate outcomes, learning and teaching activities, assessment methods, tuition fees and student finance, accommodation and professional accreditation.

## Learning and teaching

The Birmingham Business School was the first business school in the country and has built on its reputation ever since to ensure that you get the best learning and teaching experience.

### How will I be taught?

During your time at the Business School you will experience teaching through a mixture of lectures, webcasts and tutorial. We are one of the first UK universities to offer computer lead tutorials as part of some of our modules using Saasu, a cloud based accounting package.



### Contact hours

Depending on the modules you select, each week you will have between 15 and 18 hours of lectures and classes, with lecturers on hand to answer additional questions outside this timeframe.

### Assessment

Assessment will be through a combination of exams, incourse tests, group and individual coursework and presentations and will depend on the optional modules you select.

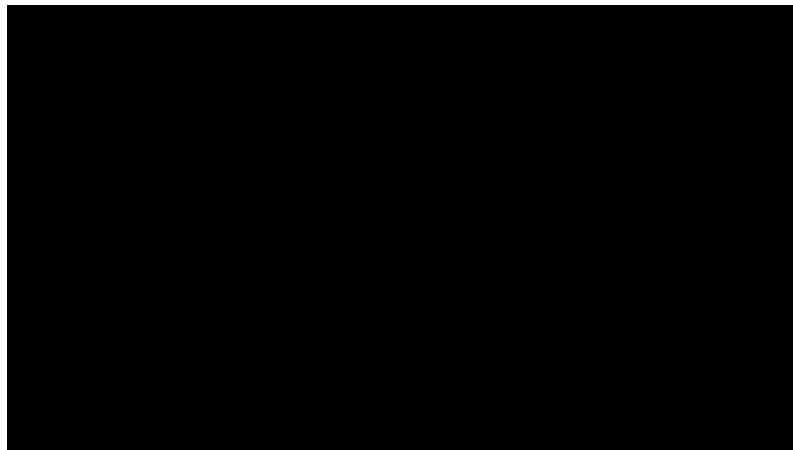

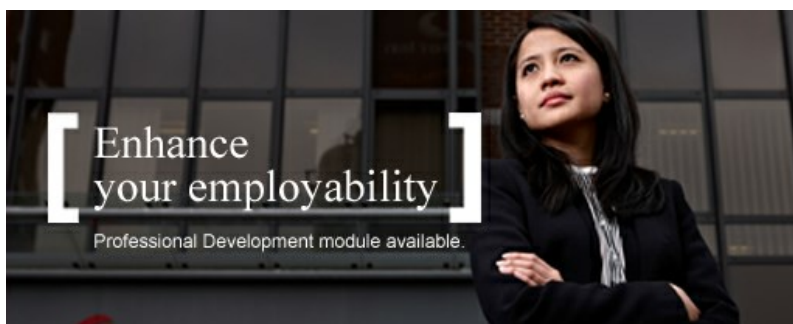
Throughout your time on the Accounting and Finance course, employability is a key area of focus. We help to make sure that you are employable through a range of department led and university wide initiatives which include:

### Professional skills module

### Careers workshop

### Professional firms involvement in your degree

Some of the classes you take as part of your course will be led by representatives from some of the most prestigious professional service firms in the country, allowing you to develop your network as well as a better understanding of what they do.

In addition, many of the firms and some of the accountancy institutes sponsor prizes awarded for academic performance in each year group.

### Internships

Many of the Accounting and Finance undergraduates take the opportunity to complete at least one internship over the summer. Between 80-90% of students undertaking an internship are offered a graduate position at their placement, conditional on successful completion of their degree. The careers network are experts in helping students secure an internship whether it be in the UK or overseas.



Through our industry links, the Business School has secured several internships with companies including Sony and Capgemini. These internships are exclusive to Birmingham Business School and can only be applied for by Business School undergraduates.
