

#### **ECUSTEC Overview**



- ☐ Trial Design: Randomised, parallel group, double blind, placebo-controlled trial
- ☐ Sample size: 134 patients
- ☐ Full trial: 6 years
  - 6 months set-up
  - 4 years recruitment
  - 1 year follow-up
  - 6 months final data cleaning and analyses
- ☐ Pilot study incorporated







## **ECUSTEC Sites**



- Tertiary centres
  - Participating as recruiting centres: 12
  - Open to recruitment: 10
- □ Great North Children's Hospital was the first site open to recruitment on the 10<sup>th</sup>
   July 2017
- □ Patient Identification Centres (PICs)
  - Confirmed Capability and Capacity (C&C): 66
  - PICs: over 100 contacted

**Pilot phase** 

- □ Pilot phase started on the date the 1<sup>st</sup> patient was randomised 11<sup>th</sup> August 2017
- ☐ Pilot recruitment phase is due to end after the 2018 STEC HUS season
  - DMEC will meet to review pilot data
  - Assess safety and tolerability



#### **ECUSTEC Pilot Phase**



- ☐ Stop/Go point is March 2019
- □ 26 patients to be recruited






- □ 20 of the 26 patients to have received the planned two doses of trial treatment
- □ At least 22 of the 26 patients to complete 6 months follow-up
- ☐ Also a progress report due November 2018

## **ECUSTEC Screening Data**



- ECUSTEC Screening data is cross-referenced against public health data
  - Public Health England (PHE)
  - NHS National Services Scotland (NNSS)
  - Public Health Wales (PHW)
- Nearly all cases of STEC HUS are being captured by ECUSTEC via screening logs and participating sites
- Reported back to NIHR EME
- Allowed recruitment barriers to be identified early on







#### **ECUSTEC Site Visits**



- □ ECUSTEC Trials Team visited the first 3 sites to recruit
  - Thank you for arranging with the Trials Team!
- ☐ Further site visits can be arranged for new sites
- ☐ Following an initial visit, only triggered visits will occur
- ☐ Trials team will require access to the Site File, CRFs and the patient medical notes





# **ECUSTEC Site Visit Outcomes**



- No issues identified with protocol compliance
- Trial related activities i.e. consent discussions were well documented in the patient notes
- No unreported SAEs and potential SUSARs
- No identified unblinding had taken place

#### **Reminders:**

- ☐ Ensure all discussions are documented and in the correct order
- Ensure 'willingness to continue' is documented at each assessment visit and prior to any trial-related activities take place
- Ensure all of the eligibility criteria is documented in the patient notes



## **ECUSTEC Site Visit Outcomes**



#### Reminders continued:

- ☐ Store a copy/document when the GP letters are sent
- ☐ Ensure Site File and Pharmacy File have the most recent signed delegation log, CVs and GCP certificates
- □ Document the version numbers of PIS, consent forms etc given to the patient/families
- Document the ECUSTEC Patient Trial Number in the patient notes
