Centre for Cities chief executive Andrew Carter said: "The challenge for Aberdeen will be to diversify its industrial structure in the years ahead, so that it is less reliant on one sector (oil and gas). "This will be crucial for the city to thrive after we leave the EU."

Aberdeen City Council leader, Cllr Jenny Laing, admitted there were "huge challenges" ahead, but said positive strides are being taken. She said: "In the past year, we have signed the £250 million Aberdeen City Region Deal, which we estimate will be worth a total of £826m when wider private investment and our own contribution are factored in. "This funding is already being put to use to foster innovation and diversification."

The mood was similarly upbeat at Aberdeen and Grampian Chamber of Commerce, which represents businesses in the city and region. Its chief executive, Russell Borthwick, said: "Clearly there are challenges associated with whatever type of Brexit outcome we see but we are hopeful that the technology, skills and innovation for which this area is renowned will stand us in good stead to see this as an opportunity rather than a threat."

The Brexit Advisory Team, made up of six of the council's most senior officials, will monitor Brexit developments and work to assess its impact on the city. Council leader John Alexander, the driving force behind a new impact report and the advisory team proposal, said Dundee had to be ahead of the game in navigating the "minefield" of Brexit.

Following the most recent round of EU funding for 2014-2020, Dundee City Council had secured £6.9 million to spend on a variety of programmes in the city. A report prepared by the office of chief executive David Martin suggests such funding is unlikely to be available in future and that Brexit will have a "detrimental" impact.
