



## **SMART Schools Study: Smartphones, social Media and Adolescent mental wellbeing: the impact of school policies Restricting dayTime use**

Hello again! Thank you for taking the time to read our previous flyer about taking part in an online survey and wearing activity monitoring watches. This information leaflet is all about taking part in a *focus group discussion*, and you have been given this leaflet because we would very much like you to consider taking part in this activity. **What will I be asked to do?** We are asking you to take part in a confidential focus group discussion with 4-6 other pupils in your class, in which we will be asking you to discuss your smartphone and social media use. Examples of topics you may be asked to discuss include;

- Your smartphone and social media use at home
- Your smartphone and social media use at school
- Your views on the school rules around smartphone use
- How your uses of smartphones and social media may influence your mental wellbeing, mental health, physical activity levels, sleep duration, behaviour at school and your attainment

The aim of the focus group is to understand the wider factors that influence pupil smartphone and social media use.

**Why have I been asked to take part?** You have been selected to take part in a focus group based on how much time you spend on your phone/social media during the school day, that you reported on in the survey.

**When will I take part?** You will be given time during the school day to complete the focus group. You will do this during lesson time and with a researcher from the study. The focus group will take place in classroom or open area within your school. The focus group will take approximately 60 minutes and will be voice recorded.

**Do I have to take part?** No. The choice to take part is up to you. You have been selected because your parents have already provided consent for you to take part. We will ask you for your assent to take part before you complete the focus group, by completing the attached form. You do not have to answer the questions if you do not want to.

**Can I withdraw?** Yes, you can withdraw yourself from the focus group, and stop participating at any moment should you wish, and you can leave the focus group. However, anything you do say during the focus group will remain in the study and be included in the reporting, as it is not possible to separate and remove individual participant data from a focus group discussion. An exception to this arrangement is if the group discussion raises a safeguarding concern, and the lead researcher will delete this section of the audio file before it is sent to transcription and used as data.

**Could I be in any harm from taking part?** We do not anticipate that the focus groups will cause you any harm. However, if you feel uncomfortable or upset for any reason, please inform a teacher in your school or your school wellbeing officer or your parent/carer.

**Why should I take part?** Your input may help to change national school policy on mobile phone use.

**What will happen to the information I give you?** We will keep information about you very safe and private for 10 years and then it will be destroyed. We will follow data protection law. We will write a report to share the findings of the study with other researchers and the public, but no-one will be able to identify you from the report. Only the researchers will know what you have said. **Will information be kept confidential?** All information that is collected about you will be kept strictly confidential. Only the researchers and the other participants in the focus group will know what you have said, and *we will not share your individual responses with anyone outside of the research team*. However, we may alert a teacher in your school if you mention anything during the focus group that raises a safeguarding concern.

The researcher will record the focus group discussion and all information will be stored electronically and securely. Your name will be removed from any reporting of the findings. Electronic files will be deleted from the system after ten years.
