What is qualitative health research?

- Provides insight into people/patients' perspectives, experiences and behaviours.
- Focus on non-numerical, detailed and rich data e.g. spoken data.
- interviews, focus groups, observations e.g. audio recordings of consultations.

What do qualitative researchers explore during trials?

- Planned implementation vs the 'reality' optimise trial processes e.g. recruitment
- The experience of trial pathways for **patients (and families)**, e.g. their satisfaction and **perceptions of treatment**.

Qualitative research in trials is evidence based.

- Example: ProtecT (Prostate cancer treatment RCT)
- Donovan et al. conducted in-depth interviews with men, and recorded recruitment conversations in the Prostate testing for cancer and Treatment (ProtecT) study.
- Lessons learnt increased the recruitment rate to the trial by 30%.

Aims for the GHD qualitative study

• To help explore the feasibility and acceptability of the trial to staff, children and carers (during the internal pilot phase)

 To explore children's and carer's perceptions – e.g. to retesting; trial participation; experience of allocated treatment

GHD Reversal Study - Qualitative data collection

- Audio recordings of main trial recruitment discussions between site staff, patients and/or their carers
- Interviews with patients & carers who have consented to the trial (within 2 weeks of randomisation, followed up at 6 months; both arms of RCT)
- Interviews with patients and carers declining to consent
- Staff interviews
- ONLY DURING INTERNAL PILOT PHASE



DON'T PANIC – vast majority of work undertaken by research fellow based at University of Birmingham (interview consent and conduct, analysis, feedback to sites etc.)

We will provide a simple CRIB SHEET to follow in relation to this part of the work

'ALL' we are asking you to do

- Consider having recruitment discussions with potential trial participants recorded – no obligation but we hope it will help staff who are recruiting to the trial (all parties to the discussion need to consent for this to happen)
- Consider consenting to take part in an interview (midway through internal pilot) – helps us understand your experience of implementing the trial
- Briefly mention the qualitative research to **ALL** potential trial participants and get consent for us to contact those that express an interest in taking part in an interview with the qualitative research fellow at UoB

Recording consultations

- No judgement will be made on site staffs' recruitment practice.
- We are not 'checking in' on sites, but attempting to uncover any challenges faced by recruiters that may undermine trial feasibility.
- Recordings and interviews help us to facilitate recruitment
- All data will be anonymised and **confidentiality will be maintained**.

In Summary

- The qualitative sub-study is **vital** to the success of the trial.
- It should be relatively light touch to facilitate research fellow will help you
- We believe with good buy in from sites, it will help you as well as us.
- We will provide a short but comprehensive crib sheet to help staff, and our research fellow will be in touch to help facilitate the qualitative research
