## Recruitment update for February

As of the 29th February 2020, we had **71** women randomised in WILL! **9** of these participants were in February.

Congratulations to the teams at; Leeds Teaching Hospital, Croydon University Hospital, St Mary's Manchester, James Cook University Hospital, St Mary's Maternity Unit, Poole, Bradford Royal Infirmary, Singleton Hospital Swansea, Royal United Hospital, Bath and West Middlesex Hospital for consenting and randomising 1 participant each to WILL.

Thanks also to **James Cook University Hospital** and **St Mary's Maternity Unit, Poole** for consenting a further **1** woman each this month.

# Recruitment target: pilot phase

As we now move into the last month of the pilot phase, lets MARCH onwards and have a final BIG push to help us reach our pilot recruitment target.

M: make every contact with potential women count

A: <a href="mailto:approach">approach</a> all potential women and <a href="mailto:aim">aim</a> to recruit <a href="mailto:at least 1 participant a month">at least 1 participant a month</a>

R: randomise!

C: consent! And call the WILL team to confirm eligibility if you need to

H: keep looking out for women with hypertension

## **Main Phase: Plan**

Sue and Julie have been contacting some potential sites to invite them to join the main phase of WILL. The aim is to run seamlessly from the pilot into the main phase of the trial. While NIHR must officially approve the transition from pilot to main phase of the trial, we need to be ready for an April start when such an approval is received.

The WILL trial will be rolled out to further sites in a staggered process so please bear with us, and look out for an email or a phone call soon. Sue will continue to support sites in the Midlands and North and Julie sites in the South.

So far, the following SIVs have been arranged: **New Cross Hospital, Wolverhampton** - 24th March, **Royal Bolton Hospital** - 3rd April, **Kingston Hospital** - 7th April, **St Michaels' Hospital Bristol** -30th April.

# Bradford - 'hug in a mug' to say Thank You



### **Research corner:**

### **Gestation-Specific Vital Sign Reference Ranges in Pregnancy**

Findings from a recent study which set out to estimate normal ranges for maternal vital signs in pregnancy have refuted the idea that a clinically significant drop in BP in first-to-mid trimester is normal. The multicentre study, which included data from over 1000 women, found that this did not happen, but that there was a rise in BP towards the end of pregnancy.

- Enter your name at the bottom of the page and enter a new date for form completion
- Save the form
