## Site and participant update: August & September

As of the 30th September 2021, we have **34** sites actively open to recruitment, and we have 215 randomised participants! 9 of those were in August and 13 in September.



## Monthly recruitment and milestones:

We are currently at 19% of both the consented and randomised targets.

Next milestones: **20% of targets 216**<sup>th</sup> randomised participant & **235**<sup>th</sup> consented participant A prize for the site(s) that reach these.



## Extension to end of recruitment: July 2023

We are waiting for confirmation from our funder to extend the trial by 18 months. meaning that the recruitment end-date is anticipated to be July 2023. and the end of the trial will be January 2024. As soon as we have received confirmation, we will be back in touch. In the meantime, please can you inform your R&D department, PI and team lead and do not hesitate to contact Katie (WILL Trial Manager) for further information.

### Database: Maternal Outcome Form/verification

Please, could you check if you have any maternal outcome forms that need data verified by the PI or delegate? To date, we are pleased that over 70% of data on these forms have been verified, and it would be great if we increase this number as this is our primary outcome. Thank you! Please let us know if you are having problems finding someone to verify data. Remember: The only sections that need data verified are: abnormal laboratory tests and maternal complications sections.

NOTE: The person you ask to review and verify the data should not have been involved in the care of the woman and be masked to the arm to which she was allocated.

## **WILL Language Survey:**

Following discussion during SIVs and our recent teleconference (SLIDO poll), we would like to find out from sites which non-English languages are most commonly spoken by women who you may approach to take part in WILL. We are considering first translating the Introductory Pamphlet, so that the basic information about WILL can be provided to potential women to read.

#### **Remote Consent:**

We are improving our remote consent process based on feedback from sites and updating the flowchart in the '**Guidance on taking remote informed consent'** document, which will be sent to you shortly once approved by the REC. The amendments are:

#### Method 1 - 'signing the consent form':

If a woman is unable to sign the consent form with a pen, she can now type her initials and name in the word version of the ICF and send the completed ICF back by email. (Please file a copy of the email sent by the woman with her completed ICF in your ISF). **Method 2- `witness':** 

The 'witness' now does not need to be GCP-trained or named on the Delegation Log. **Examples of who could be a witness are**: administrative assistant, midwife, HCA, nurse, research nurse, or doctor. It is best if the witness is Trust staff as they are bound by Trust confidentiality rules.

## NICE: Updated guidance - Induction of Labour

This 2021 updated guideline (currently draft) highlights the need for research into timing of birth for conditions associated with increased maternal



of birth for conditions associated with increased maternal and perinatal risk at term, such as women with chronic or gestational hypertension. Therefore, the WILL trial is really important for these women.

#### ucing labour (update) elopment [GID-NG10082] Expected publication date: 04 November 2021 Summary of guideline that supports WILL:

• No specific guidance for what GA women with chronic or gestational hypertension should be induced

- "uncomplicated singleton pregnancies should be offered induction at 41 weeks..."
- ''more research should be done to establish at what GA induction of labour should be offered in the groups of women who may be more likely to experience adverse outcomes if their pregnancy continues."


