

Famous female WILLs!

Some sites have had famous Williams to promote the WILL trial, but how many female WILLs can you think of? We found 3 to start us off:

Wil Van Gogh (Wilhelmina/Willemina): 16th March 1862 - 17th May 1941 Wil was a nurse and early feminist. Sister of Vincent Van Gogh. She also turned her hand at midwifery in January 1890 when she visited Paris and helped her other brother's wife with the birth of her first baby. Sadly, she was admitted to an asylum in 1902 where she stayed until her death almost 4 decades later.



Wilma Rudolph: 23rd June 1940 - 12th November 1994

An Olympic athlete who won gold medals in the 100m, 220m and 4x100m relay in 1960. She contracted polio at the age of 5 and needed to wear a leg brace until she was 12 years old. Overcoming this she went on to be known as the fastest woman in the world in the 1960s and became a role model for black and female athletes, causing gender barriers to be broken at previously all-male running events.



And last but not least...

Wilma Flintstone: 1959 - present

Born in 'Arkanstone', this strong-willed, level-headed cavewoman first made her appearance in 'The Flagstones', which soon became 'The Flintstones'. Married to Fred, mother to Pebbles and best friend to Betty, Wilma is a housewife, news reporter for Bedrock's local newspaper 'The Daily Granite' and a caterer (her specialty being 'gravelberry pie'). In her spare time, Wilma also enjoys volunteering for various charitable and women's organisations in Bedrock.

Database queries

Thanks very much to all sites for addressing data queries during these challenging times when they are due. Please do continue to ...

- Run the Active Data Queries report on the database regularly to check for any new queries.
- Complete CRFs when they are due.
- Update screening forms for participants who were screened early once their GAs are within the eligibility window $(36^{+0} \text{ to } 37^{+6})$, even if they don't meet other eligibility criteria. This helps the team to identify barriers to recruitment.
- Complete the Reconfirmation of Eligibility and Randomisation form for consentedonly participants whilst they would still be eligible for recruitment, i.e. before they reach 38⁺⁰. If you are unable to do so, there is a workaround that involves completing a hard copy of the form, scanning and sending to will@trials.bham.ac.uk so that Ruth can complete the form on the database on your behalf.
- Look out for the Data Query Management emails which may detail queries that cannot be raised directly on the database, e.g. queries on CRFs 2, 8 and 9
- Please get in touch if there are any queries about which you are unsure.

Information on this page will help you with any discussions you have with women and doctors/midwives caring for them about WILL.

We will feature a different topic each month. This month is:

Membrane Sweeps

Membrane sweeping is an intervention offered to hasten the onset of labour. However, membrane sweeps are not labelled as an official method of induction of labour in many UK hospitals.

There are no ongoing trials to inform practice in the UK, so should we be offering membrane sweeps or not?

NICE describes membrane sweeping as an adjunct to induction of labour rather than a method of induction of labour.

(NICE 2008)

Membrane sweeping compared to no treatment is more likely to result in labour onset and reduces the incidence of formal induction of labour (evidence of low certainty)

(COCHRANE 2020)

Membrane sweeping may cause vaginal bleeding and discomfort

(NICE 2008)

Membrane Sweeps

However, membrane sweeps compared to no treatment do not increase the chance of spontaneous vaginal birth.

(COCHRANE 2020)

Even though women acknowledged that membrane sweeps were uncomfortable, 88% would choose to have one in their next pregnancy.

(COCHRANE 2020)

There was also no difference in the risk of Caesarean birth between membrane sweeping and no treatment.

(COCHRANE 2020)

WILL and membrane sweeps

- If membrane sweeps are offered to women taking part in WILL and they accept,
 please enter this information on the database.
- In WILL, we collect the date of the first membrane sweep following randomisation and the number of times it has been performed. This will provide information about whether membrane sweeps had any impact on the start of labour.

True or False?

- Q. If a membrane sweep is not possible due to not being able to enter the cervix, cervical massage may be used instead.
- A. True. According to NICE guidance (CG70), if the cervix is not open enough to admit a finger, massaging around the cervix in the vaginal fornices may achieve a similar effect.
