### **Current and Projected Research**

- (1) My main current research is in developing macroeconomic models with imperfect asset substitutability between short-term and long-term government bonds. One application involves consideration of the macroeconomic effects of fiscal consolidation programmes. The work involves both theoretical modelling and econometric analysis. The approach should also be very relevant in explaining the effects of both conventional and unconventional monetary policies such as quantitative easing.
- (2) Property taxation reform in the United Kingdom. This involves putting together a proposal for a suitable and politically feasible package of reforms to council tax, business rates and stamp duty.
