'CHANCELLOR'S FULL SCHOLARSHIP AWARD'
INTERNATIONAL TEAM, SRO, EXTERNAL RELATIONS
TERMS & CONDITIONS 2019/20

1. Definitions

In these terms and conditions the following expressions shall have the following meanings:

- 1.1 "Academic Year" means the University's year of academic study.
- 1.2 "Leave of Absence" means a recognised and authorised break from studies approved in accordance with the University's Code of Practice on Leave of Absence Procedures.
- 1.3 "Programme" means the academic programme for which the Student has registered.
- 1.4 "Scheme" means the University's Dubai 'Chancellor's Full Scholarship Award' scheme.
- 1.5 "Scholarship" means an award pursuant to the Scheme payable at the absolute discretion of the University.
- 1.6 "Student" means a registered student of the University who has commenced a programme of study at the University of Birmingham Dubai Campus in 2018 or will commence a programme of study in 2019 and who is in receipt of a Scholarship.
- 1.7 "University" means the University of Birmingham, Edgbaston Birmingham B15 2TT UK.

2. Award

Whenever the University makes and the Student accepts the award of a Scholarship, the terms and conditions set out below shall apply unless otherwise expressly excluded in whole or in part.

3. Conditions of Award

3.1 A Student in receipt of a Scholarship shall:

- 3.1.1 be entitled to receive the Scholarship payment for each year of the Student's registration on the Programme at the University of Birmingham Dubai Campus unless otherwise agreed in writing;
- 3.1.2 undertake each and every year of their Programme at the University of Birmingham Dubai Campus. This Scholarship is not transferable to study at the University of Birmingham UK campus, except in the Year 2 under the UK Exchange Scholarship Award. This Scholarship cannot be transferred across degree levels or between different degree programmes.

4. Payment

- 4.1 Payment of the Scholarship shall normally be made by way of a tuition fee discount applied for each Academic Year of study on the relevant Programme.
- 4.2 The Scholarship does not cover the full cost of living at the University of Birmingham Dubai Campus or any visa, travel or other expenses associated with studying in the United Arab Emirates and the Student is responsible for meeting such costs and expenses.

5. Termination

- 5.1 In any of the circumstances set out in this clause below the Scholarship shall be withdrawn and the University shall make no payment (or no further payment) of the Scholarship:
 - 5.1.1 the Applicant fails to secure a visa and does not register at the University of Birmingham Dubai Campus
 - 5.1.2 the Student transfers to another course or programme of study which does not meet with criteria set for the Scholarship
 - 5.1.3 the Student permanently leaves the University due to illness (whether or not following a Leave of Absence)
 - 5.1.4 the Student leaves the University voluntarily for reasons other than illness
 - 5.1.5 the Student is required to withdraw from the University pursuant to disciplinary or fitness to practise proceedings
 - 5.1.6 the Student otherwise fails to complete satisfactorily the requirements of the Programme
 - 5.1.7 the Student fails to progress satisfactorily through each and every year of the Programme due to the requirement to repeat an Academic Year.

- 5.2 The University reserves the right to demand repayment of any instalment or instalments (or part thereof) of the Scholarship made to the Student during the Academic Year in the circumstances set out in 5.1.2 and 5.1.5.

6. Leave of Absence

- 6.1 In the event that the Student takes, or is required to take, a Leave of Absence during the Academic Year any payments otherwise due to the Student pursuant to clause 5 above shall be suspended until such time as the Student has re-registered.
- 6.2 Upon re-registering the Student will be paid, in accordance with clause 4.1 above, the balance of any Scholarship due from the Academic Year when the Leave of Absence was taken.
- 6.3 If the Student fails to return to the University after such Leave of Absence then the provisions of clause 5.1 above will apply.

7. Miscellaneous

- 7.1 A Student who is required to repeat the Academic Year will not be eligible to receive a further Scholarship in respect of the repeated year unless there are exceptional circumstances approved by the University.
- 7.2 A Student may be eligible to receive any other scholarships or bursaries offered from time to time by the University.
- 7.3 Any dispute or complaint arising in connection with the Scheme should in the first instance be addressed in writing to the Director of Campus Operations at University of Birmingham Dubai.
- 7.4 The Chancellor's Full Scholarship and Provost's Academic Scholarship Awards are invite-based awards which are exclusively selected by our Scholarship Panel and are limited.

8. GETEX Scholarship

- 8.1 The 25% GETEX Scholarship will be awarded on a first come first serve basis, only during the exhibition on 17th, 18th and 19th April 2019 at the GETEX UOBD stand.
- 8.2 The Scholarship will be awarded on the basis that all the required original documents are presented at the GETEX UOBD stand, along with a completed application.
- 8.3 Applicants must receive a Conditional Offer Letter based on the above to be offered a GETEX Scholarship.
- 8.3 The 50 undergraduate and postgraduate scholarships will be awarded on a distributed basis 5x subject area:
- First 5 applicants for BSc Accounting & Finance
 - First 5 applicants for BSc Business Management
 - First 5 applicants for BSc Money Banking & Finance

- First 5 applicants for BSc Economics
- First 5 applicants for BSc Mechanical Engineering
- First 5 applicants for BSc Computer Science
- First 5 applicants for Foundation in Psychology
- First 5 applicants for MSc Computer Science
- First 5 applicants for MSc International Business
- First 5 applicants for LLM Commercial Law

8.4 Get Into Teaching GETEX Scholarship will be awarded on a first come first serve basis, to the first 5 applicants for PGCE programmes.
